NEW BUSINESS & COMMUNICATIONS – President Aho

MEMBERS INPUT (Non-Agenda Items)

Randy Keller cited the lack of consistent enforcement of Section 18 regarding sight screening of trash containers. President Aho shared that Manager has added an individual to the staff to improve enforcement of Deed Restrictions issues.

Alan Leonard inquired as to why we are spending money on all the sector signs when no one really uses them. Also, he asked how many discreet users there are to the Park and questioned if it is worth what we are spending on it. His third question related to the apparent lack of

representation of the "newer" sections of RWA. Stating that of the current BOD members, one resides in Oakland Hills, one in Pebble Beach, and 3 in Pinehurst. Two don't live within the Circle at all. He also mentioned one Director is a lot owner in Pine Valley but does not reside there. He advocated for one representative from each segment.

DIRECTOR INPUT

Director Froggatt expressed his disappointment in the failure of the mask mandate. He also stated that there are a lot of people in the RWA who are on fixed incomes and he wanted to encourage keeping fines low and do all that is possible to keep our assessment at \$190.

Director Traverso would like to make sure that the ideas provided during member input are captured.

Director Eldred provided to the Board a list of groups that were "grandfathered" in or were permitted use of the RWA facilities prior to any fee schedules.

Director Traverso motioned to adjourn. 2nd Director Froggatt.
